

Terms and Conditions for the “50 cents Kopi or Teh for VCC and VDC members” Promotion

These terms and conditions shall apply to the 50 cents Kopi or Teh for VCC and VDC members Promotion, organised by Shell. By taking part in the Promotion, you agree to be bound by these terms and conditions, and the decisions of Shell in relation to and in connection with the Promotion.

1 Definitions

- 1.1 “Shell” means Shell Eastern Petroleum (Pte) Ltd.
- 1.2 “VCC” means Shell Value Care Cardmembers.
- 1.3 “VDC” means Shell Value Drive Cardmembers.
- 1.4 “Promotion” refers to this 50 cents Kopi or Teh for VCC and VDC members Promotion.
- 1.5 “Promotion Period” means 1 March 2020 to 31 August 2020 (both dates inclusive).
- 1.6 “Redemption Period” means the period of 0000H on 1 Mar 2020 – 2359H on 31 Aug 2020.
- 1.7 “Eligible Cardmembers” means customers who are valid and existing (i) Shell Value Care Cardmembers and (ii) Shell Value Drive Cardmembers. For avoidance of doubt, Shell Escape Cardmembers, Corporate Shell Card and all commercial and business Credit and Debit cards are excluded from this Promotion.

2 Promotion

- 2.1 The promotion is open to all Eligible Cardmembers subject to the terms and conditions herein.

 - 2.2.1 Each Eligible Cardmember may purchase a cup of kopi or teh for SGD \$0.50 from the Kopibox vending machine located at any of the 32 Shell service stations in Singapore listed below.

2.2.2 All Eligible Cardmembers will be required to present their VCC or VDC card to the cashier at Shell service stations in Singapore to purchase a cup of kopi or teh at SGD \$0.50.

3 General

- 3.1 In the event of any inconsistency or discrepancies between these terms and conditions and any advertising, promotional, publicity, brochure, marketing or promotional material relating to or in connection with the Promotion, these terms and conditions will prevail.
- 3.2 Shell shall not be responsible or liable for any loss whatsoever to any person in connection with this Promotion howsoever arising, including any error in purchasing the kopi or teh at SGD \$0.50.
- 3.3 Shell is not liable for any injury, loss or damage whatsoever or for any charges, costs or expenses of any kind whatsoever suffered or incurred as a result of or in connection with the Promotion, including, but not limited to, the loss of life, injury to person and/or loss or damage to property.
- 3.4 Shell has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion. Shell's decisions on all matters relating to this Promotion shall be final, conclusive and binding on all parties concerned and no payment or compensation will be given or paid by Shell to any person (including the Eligible Cardmember). Shell shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter relating to the Promotion and no appeal, correspondence or claims will be entertained.
- 3.5 Shell reserves the right at its and their reasonable discretion to unilaterally terminate the Promotion or vary, delete and/or add to any of these terms and conditions from time to time without prior notice, including but not limited to cancelling, terminating or suspending this Promotion, the eligibility terms and criteria and the timing of any act to be done, and all Eligible Cardmembers shall be bound by these variations, deletions and/or additions.

- 3.7 The terms and conditions are governed by the laws of Singapore, and all participating Eligible Cardmembers shall be deemed to have irrevocably agreed to submit to the exclusive jurisdiction of the Singapore Courts.
- 3.8 A person who is not a party to any agreement governed by these terms and conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any terms of such agreement.
